1. This invitation for bids follows the General Procurement Notice for this project that appeared online on 21<sup>st</sup> July 2022.

The Federal Government of Somalia has received financing from the African Development Bank Group toward the cost of the Additional Financing to Build Resilience for Food and Nutrition Security (BREFONS) project and intends to apply part of the proceeds toward payments under the contract **Supply and installation of Galvanized Chain-link Fence (Wire Mesh) with All Accessories (Additional Financing) in Galmudug, Hirshabelle, Southwest and Jubbaland States of Somalia (in Four Lots)**. The Ministry of Livestock, Forestry and Range serves as the Executing Agency of the project while Save the Children International fulfills the role of the project's Implementing Agency. The Executing Agency will process the payments for this contract using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing.
